- The complete control of the facility and equipment shall at all times remain with Sandla Preparatory School through its management, supervisory, custodial and maintenance employees, excluding contents supplied by the RENTEE or its members.
- The RENTEE shall obey and observe all laws, and regulations of the City of Albuquerque.
