Terms and Conditions of Master Calendar Event Request

Sandla Preparatory School reserves the right, entirely at its discretion, to accept or reject any application for the use of any facility or area under its jurisdiction.

- The complete control of the facility and equipment shall at all times remain with Sandia Preparatory School through its management, ory, custodial and maintenance employees, excluding contents supplied by the RENTEE or its members.
- The RENTEE shall obey and observe all laws, and regulations of the City of Albuquarque

HOLD HARMLESS

RENTEE agrees to indemnify and hold harmless Sandia Preparatory School harmless from and against any and all loss, claims, actions, damages, liabilities, costs and expenses, including reasonable legal fees, in connection with loss of life, personal injury, damage to properly or any other loss or injury whatsoever arising from or out of any occurrence in, upon or at the leased premises or the occupancy or use by the RENTEE of the leased premises or any part thereof, or occasioned wholly or in part by any act or omission of the RENTEE or by anyone permitted to be on the leased premises or the market by the RENTEE. If Sandia Preparatory School shall, without fault on its part, be made a party to any litigation commenced by or against the RENTEE, then the RENTEE shall protect indemnity and hold Sandla Preparatory School harmless and shall pay all costs, expenses and reasonable legal fees incurred or paid by Sandia Preparatory School in connection with such litigation. The Licensee shall also pay all costs, expenses and legal fees that may be incurred or paid by Sandia Preparatory School in enforcing the terms coverants and conditions of this Agreement, unless a court of law shall decide otherwis

Further, such insurance shall not be cancelled or permitted to lapse unless the insurer notified Sandla Preparatory School in writing at least thirty (30) days prior to the date of cancellation. Sandia Preparatory School reserves the right to request, from time to time, such other amounts and types of insurance as it may reasonably require; failure to satisfactorily meet these conditions relating to insurance shall be deemed a breach of this Agreement.
